Following the Registrar’s Directive from the Bereavement Authority of Ontario and direction from our public health officials, the Town of Parry Sound has implemented the following Cemetery Use - COVID-19 Safety Measures to ensure the safety and well-being of visitors to the Township’s cemeteries and of municipal staff.

We cannot be certain that a person (of any age) will not contract COVID-19 at any one of our cemeteries but we have taken the steps required to develop the Cemetery Use - COVID-19 Safety Measures to help keep our community safe. We need to work together to ensure that our cemeteries stay as safe as possible for every person entering our cemeteries.

As the representative of the Service attendees, you are required to read and confirm that you understand the COVID-19 safety measures for cemetery use as set out in this document. Furthermore, as the representative of the Service attendees, you are required to take steps to ensure that all attendees at the Service act in accordance with the Cemetery Use - COVID-19 Safety Measures. You are required to complete the below check list and sign this Cemetery Use – COVID-19 Safety Measures. Please submit the completed and signed document to the Township prior to the requested burial date and time.

<p>I understand that I, as the representative of the Service attendees, am responsible for ensuring that attendees adhere to the following measures:</p> <ul style="list-style-type: none"> • All persons entering the cemetery will be required to wear a mask while at the cemetery; • All persons at the cemetery will be required to maintain a safe distance of 2 metres between themselves and others not in their immediate household at all times; • Anyone exhibiting symptoms of COVID-19 within the last 10 days has been instructed to not attend the Service. Symptoms include fever, chills, new or worsening cough, shortness of breath, sore throat and new muscle aches or headaches; • Anyone who has been instructed by public health to isolate, or has arrived from outside of Canada, or has had contact with a confirmed COVID-19 case within the last 14 days has been instructed to not attend the Service; • Any other measures recommended by public health officials. 	<p>Initial Here</p>
