- The current uses of land that is adjacent to the subject land;
- The location, width and name of any roads within or abutting the subject land, indicating whether it is an unopened road allowance, a public travelled road, a private road or a right-of-way;
- If access to the subject land will be by water only, the location of the parking and boat docking facilities to be used; and
- The location and nature of any easement(s) affecting the land.

Supplemental information, as noted in the Official Plan may be requested upon further review of the application and prior to deeming an application complete.
